47RH/47RE/48RE General Transmission Warranty

Applies to Superstock, Towmaxx, Stage One and Stage Two 47/48 Transmissions. Does not apply to manual valve body equipped transmissions.

- Muldoon's Performance Transmissions (MPT) provides a non-transferable, two-year unlimited mileage warranty on transmission workmanship and materials from the date of invoice. MPT reserves the right to amend their warranty at any time.
- MPT's liability under the warranty term is limited to repair or replacement, at its discretion. MPT reserves the right to determine the course of action to rectify any warranty repair or replacement applicable to warrantable transmissions.
- Warranty Inclusions; Transmission are warranted to be free from defects in workmanship and materials.
 Electrical components and warranty related freight charges are covered from a period of ninety days after invoice date.

Warranty exclusions;

- Broken transmission shafts
- Sheared/loosened crankshaft bolts
- Rental vehicle fees, lodging, loss of use, loss of time or any per diem damages.

- Broken transmission sprags
- Freight charges after a period of ninety days
- Labor and materials for transmission installation

- Sheared/loosened torque converter bolts
- Towing charges
- Electrical components after a period of ninety days.

Transmission damages from the following factors;

- Overheating
- Low fluid level
- Water contamination
- Improper installation practice

Abuse

- Improper vehicle towing
- Case cracks/ loosened hardware from driveline vibrations
- Transmissions that do not have pressures checked, coolers hot-flushed WITH hot flush machine and installation by a certified automotive shop. If hot flush is not available, all transmission lines and coolers must be replaced. In this event, both image and invoice proof must be provided to MPT for warranty eligibility.
- Transmission cooler configuration; Omission of heat exchanger / torque converter cooler without supplemental 60,000 BTU fan equipped auxiliary cooler in concert with original equipment or equivalent front transmission cooler. Recommended auxiliary cooler for this application is Derale # 15870.
- Failure to follow recommended service intervals. Initial service must be completed at 1,000 miles. During initial and all subsequent services, the transmission fluid and filter must be replaced and bands adjusted. A Dacron style felt filter for 1994-1995 Ram 2500/3500 must be used. Thereafter, the transmission must have the fluid changed and bands adjusted every 15,000 miles or after every 15 competition events, whichever comes first. Warranty is only eligible if serviced by a transmission shop. If customer cannot provide service records that include mileage, date of service, quantity of fluid, type of fluid, and filter part numbers, then they will not be eligible for warranty claims.
- Tampering of transmission will void warranty.

Ship out/local pickup non MPT installed transmissions only

- Failure to submit completed warranty registration sheet within 30 days of transmission receipt will result in warranty forfeiture.
- Unless agreed with MPT, failure to send in transmission and torque converter core will void warranty.

47RH/47RE/48RE Refresh & Competition Transmission Warranty

Applies to Refreshed, Stage 3, Stage 3.5, Stage 4 Automatic valve body transmissions and any variant MPT transmission equipped with manual valve body.

- Muldoon's Performance Transmissions (MPT) provides a non-transferable, one-year unlimited mileage warranty on transmission workmanship and materials from the date of invoice. MPT reserves the right to amend their warranty at any time.
- MPT's liability under the warranty term is limited to repair or replacement, at its discretion. MPT reserves the right to determine the course of action to rectify any warranty repair or replacement applicable to warrantable transmissions.
- Warranty Inclusions; Transmission are warranted to be free from defects in workmanship and materials. Electrical components and warranty related freight charges are covered from a period of ninety days after invoice date.

Warranty exclusions;

- Broken transmission shafts
- Sheared/loosened crankshaft bolts
- Rental vehicle fees, lodging, loss of use, loss of time or any per diem damages.

- Broken transmission sprags
- Freight charges after a period of ninety days
- Labor and materials for transmission installation

- Sheared/loosened torque converter bolts
- Towing charges

• New Electrical components after a period of ninety days.

Transmission damages from the following factors;

Thereafter, the transmission must have the fluid changed and bands adjusted every 15,000 miles or after every 15 competition events, whichever comes first. Warranty is only eligible if serviced by a transmission shop. If customer cannot provide service records that include mileage, date of service, quantity of fluid, type of fluid, and filter part numbers, then they will not be eligible for warranty claims.
- Tampering of transmission will void warranty.

Ship out/local pickup non MPT installed transmissions only

- Failure to submit completed warranty registration sheet within 30 days of transmission receipt will result in warranty forfeiture.
- Unless agreed with MPT, failure to send in transmission and torque converter core will void warranty.
